## **#1: Language** You can't effectively shepherd across languages.




Problem #1: The church has to rely on "unicorns."




Problem #2: The pastor has an unfair ratio (1:600).

## **#2: Elders** Churches should be led by multiple elders.

#### **Elders teach the Bible**

•1 Timothy 3:2: An overseer, then, must be above reproach, the husband of one wife, temperate, prudent, respectable, hospitable, able to teach...

#### **Elders teach the Bible**

• Titus 1:7-9: For the overseer must be above reproach... holding fast the faithful word which is in accordance with the teaching, so that he will be able both to exhort in sound doctrine and to refute those who contradict.

#### **Elders shepherd and exercise oversight**

•1 Peter 5:1-2: Therefore, I exhort the elders among you, as *your* fellow elder and witness of the sufferings of Christ, and a partaker also of the glory that is to be revealed, shepherd [pastor] the flock of God among you, exercising oversight [oversee]

### Elders provide examples to the flock

•1 Peter 5:2b-3: not under compulsion, but voluntarily, according to *the will of* God; and not for sordid gain, but with eagerness; nor yet as lording it over those allotted to your charge, but proving to be examples to the flock.

### There should be multiple elders

•Acts 14:23: Paul and Barnabas appointed elders for them in each church and, with prayer and fasting, committed them to the Lord, in whom they had put their trust.

## There should be multiple elders

•**Titus 1:5:** The reason I left you in Crete was that you might put in order what was left unfinished and appoint **elders** in every town, as I directed you.

# Elders are godly men

• Titus 1:6-9: An elder must be blameless, faithful to his wife, a man whose children believe and are not open to the charge of being wild and disobedient. Since an overseer manages God's household, he must be blameless-not overbearing, not quicktempered, not given to drunkenness, not violent, not pursuing dishonest gain. Rather, he must be hospitable, one who loves what is good, who is selfcontrolled, upright, holy and disciplined. He must hold firmly to the trustworthy message as it has been taught, so that he can encourage others by sound doctrine and refute those who oppose it.




•1 Timothy 5:17: The elders who direct the affairs of the church well are worthy of double honor, especially those whose work is preaching and teaching.



•Hebrews 13:7: Remember your leaders, who spoke the word of God to you. Consider the outcome of their way of life and imitate their faith.





# What would change?

- Closer to the Bible
- Clearer for congregations and leaders
- •Less dependent on paid pastors
- More shepherding support for pastors
- •Leaders not as stretched
- •Enforce elder (vs. deacon) qualifications
- Stronger accountability for pastors
- Potentially more trust in elders

# What wouldn't change?

- •Having multiple leaders
  - Some current leaders could be elders
- •Requiring Christlike character for leaders






# **Unity in Vision**

- •Each congregation plays a part in this.






Conclusion: The congregations can have meaningful unity in belief and unity in vision, without requiring uniform practice.




# Unity in Belief We should be *united* in "die for" and "divide over" issues but *free* in "debate" and "don't care" issues.




Unity in Vision We should be united in the vision of making disciples in Sacramento and beyond.

# #4: We need each other


The vision requires each congregation to work together.




Problem with staying together: It's difficult. We get in each other's way.
